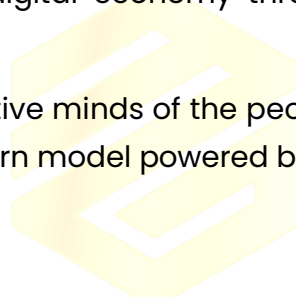
## INTRODUCTION

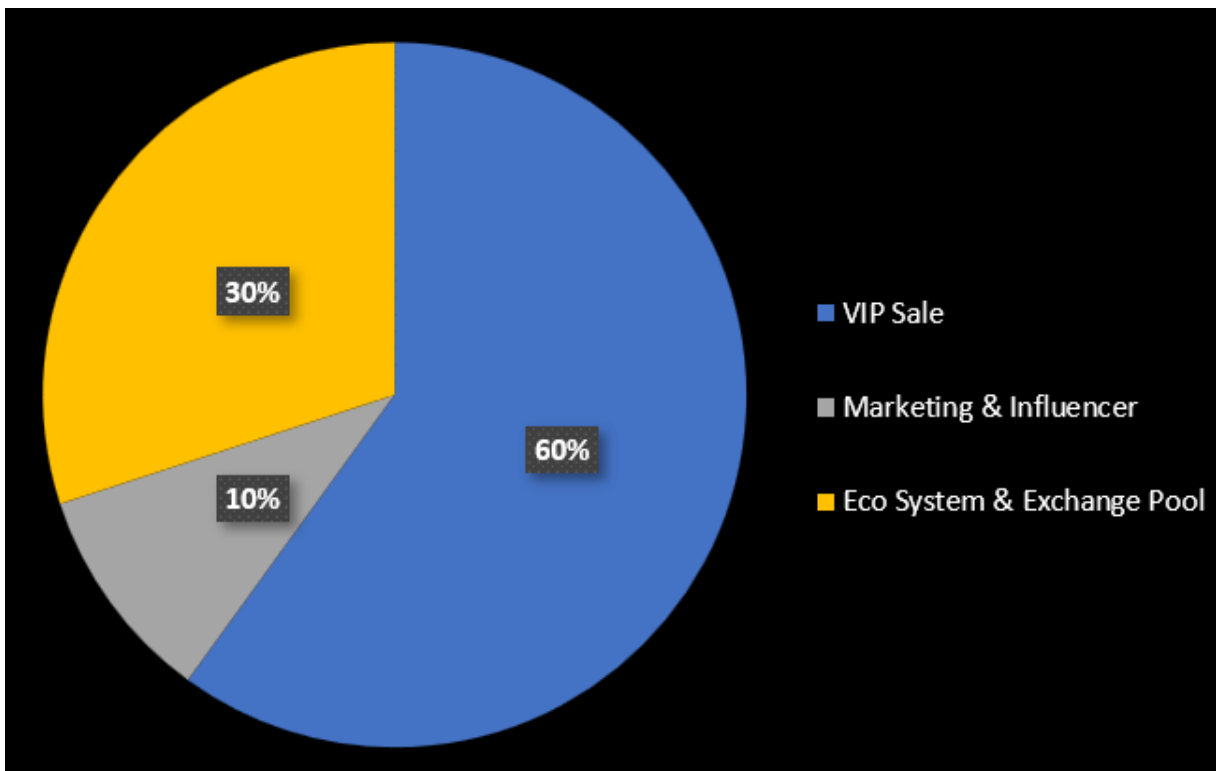
MetaGlobal Tourism will be the network that links the many fragmented virtual worlds together, connecting the metaverse, and our digital futures.
